Other Fees & Disclosures:

Late Payment Fee:

\$15.00 or the amount of the required minimum payment, whichever is less, if you are 11 or more days late in making a payment.

Cash Advance Fee (Finance Charge):

\$5.00 or 2.00% of the amount of each cash advance, whichever is greater, however, the fee will never exceed \$25.00.

Returned Payment Fee:

\$20.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee:

\$25.00.

Document Copy Fee:

\$5.00.

Emergency Card Replacement Fee:

\$150.00.

PIN Replacement Fee:

\$5.00.

Rush Fee:

\$50.00.

Statement Copy Fee:

\$5.00.
