- Vendors may start setting up at 11:00AM & arrive no later than 12:00PM
- Vendors booths must be ready to go by 12:30PM
- All booths must be staffed throughout the event
- All participants must be set up until 5:00PM
- Vendors must provide their own tables, chairs, tents, and canopies, as needed.
- Vendors are limited to their vendor space.
- **All vendor spaces are 10 X 10.**
- Food vendors may not dump used cooking oils/grease at the event. YOU MUST take your used oils/greases with you for disposal.
- No bikes, skateboards, or unauthorized motor vehicles allowed.
- Vendors may not bring, display, or sell any offensive or potentially harmful items to our event. You will be asked to leave if these items are found at your booth. Tidemark and Revelation reserve the right to determine what items are offensive or potentially harmful to the attendees and workers at the event.
- Noiseless generators are required.
